From one of the many readings on Christmas Eve: *Therefore, the Lord himself will give you a sign*: *The virgin will be with child and will give birth to a son, and will call him Immanuel.* (Isaiah 7:14)

From my pastor's sermon the same night: Immanuel means God is with us.

I was honored to be elected by you to serve on the Camp Lutherwood Oregon Board of Directors on Jan. 26, 2019. During that meeting, a historic vote was taken by the Association to approve the Capital Campaign which included a huge project: The creation of a year-round retreat center (Guest Lodge)! This Guest Lodge will allow Camp Lutherwood to offer ministry programming throughout the year more comfortably and, by doing so, allow for better financial security for the core of our mission to create intentional experiences where people can access the outdoors for restoration, play, and growth.

Shortly after that meeting, on April 12th there was a fire — a devastating fire. What a time to be on the board! It was amazing to see the generosity of Lutherwood supporters who helped the camp get back on its feet. Scrambling, we used big tents for a time and then the beautiful new dining hall was constructed and has been put to good use. God was with us!

Then COVID happened, which shut everything down. How do you run a camp with no campers? With the efforts of Andrea, Melissa, Tom, and the leadership of the board, things were reduced to "bare bones," and we survived with the generosity of Lutherwood supporters. Yet again, God was with us.

This year, the property adjacent to Lutherwood became available. It had most recently been a marijuana growing operation. With your vote of approval, the property was purchased, which allows for more access to Highway 36, housing space for staff, a barn for maintenance equipment, unimpeded access to our water tower, and much more. God was with us!

Moving forward in 2023, we must continue to find quality individuals to serve on the board of directors. I am happy to report that the current members are all doing a wonderful job. We must also continue to staff camp with dedicated people with the desire to live out our mission. Finally, we must focus on the Capital Campaign to raise the funds needed for the year-round Guest Lodge. And I pray, God, continue to be with us!

Thank you to the Lutherwood Staff as well as all of you who have supported the camp's ministry in 2022. We can't do this work without you. Please read all the included staff reports in this document so you too can celebrate the many ways God has been with us. We look forward to 2023!

2021 Annual Meeting Minutes of the Association

Saturday, February 5, 2022 via Zoom

Draft Minutes

Board Members in Attendance: Barry McPherson, Joanna Palmer, Eric Bohlmann, Lennie Torgerson, John Andrea, Debbie Knebel, Peter Hoelter, Don Richard, and Bruce Henderson.

15 voting representatives from Association churches.

Melissa welcomed everyone and reviewed how to vote on a Zoom meeting.

Opening prayer by Andrea Scofield, Executive Director.

Andrea introduced current Camp Lutherwood staff and interns.

A video to the song "Intergenerational" was played with photos of different summer programs.

Barry McPherson, Board President welcomed everyone and introduced the current Board of Directors.

Business Meeting

At 9:51 am, Barry called the meeting to order. There were 15 voting representatives present so he declared a quorum.

Approval of the 2020 minutes: Jim Krueger moved to approve the 2020 annual meeting minutes as presented. Seconded by Bill Johnson.

There was no discussion. Voted and passed unanimously.

2021 Staff Reports | Andrea Scofield, Executive Director:

A huge thanks to the weekly volunteers who come every Wednesday to work on the grounds doing multiple projects.

Andrea highlighted the new staff that were hired within the last year. We celebrated having more staff hired back after pandemic restrictions were changed.

A thank you to the Murdock Trust that continues to help support Camp's Internship Program. Michael and Gunnar, our two current interns, are working on different projects that are explained more in their report section in the Annual Report. Both interns are a huge support in getting Camp ready for the American Camp Association visit this year.

A huge thank you to Melissa for the multiple roles she took on to get Camp up and running last summer.

Andrea shared that 2021 summer camp was finished with no known COVID outbreaks. Summer camp did not have to pause or stop due to illness, nor did anyone report back that they were sick after being at Camp.

Camp was able to have Outdoor School in the spring for dayonly sessions. Camp did host a few other programs later in the year as COVID restrictions changed.

Treasurer's Report: Libby Isensee, Board Treasurer

2021 Financials Presented

Libby explained the charts in the annual report. Most of the income was almost evenly split between grants, donations, and rental groups.

A huge celebration that the pool loan has been paid off! Camp Lutherwood is debt free!

Questions Asked of Libby and the Board: Does the value of physical assets on the Camp's ledgers go down each year? Andrea stated that Lutherwood has not historically done depreciation for physical assets. It is noted in the annually CPA-reviewed financial statements.

A question was asked on clarification of funds for the Capital Campaign fund and what are general funds. Libby broke out what the Capital Campaign funds were as of 12/21 and what is general cash.

A question was asked on how often Camp has its financial books reviewed. Camp Lutherwood contracts the services of a CPA for a financial review annually.

The Year Ahead | Andrea Scofield & Melissa Singletary:

The Board and staff are working on strategic planning and long-range planning of one to three years and one to five years. Evan Moilan, Camp's Capital Campaign Consultant, has been working with the Strategic Planning committee. Surveys were sent out and the committee is working on compiling the data. Expect to have a completed plan by May 2022.

Questions the Board and Staff are Asking: How do we become more inclusive? How do we plan to be more open to

all people? How do we plan for future buildings and how to make older buildings more accessible?

Empowering Access came out last year and went through the Camp with Andrea and the staff. This consultation was paid for by a grant. They looked at the wording on Camp's website, and how Camp and buildings are set up. This work will be ongoing. One thing learned is that the whole Camp does not have to be accessible, but to be aware and open about what is open to other abilities and what is not. Planning for future buildings and how to make older buildings more accessible will be a result of Empowering Access's consultation.

Capital Campaign Update | Melissa Singletary: Melissa provided an update on the Capital Campaign. In the annual report, there is a graph that shows how much has been raised.

The dining hall and bathhouse have been fully paid for. The bathhouse just needs to be built. Camp is currently in the process of working through the permit section for the bathhouse.

We have about \$500,000 towards the retreat center and will continue to raise about \$2.5 million with the Capital Campaign. The primary focus for Andrea and Melissa is on sharing the story of the Capital Campaign Fund and the Lodge/Retreat Center Project Phase 1.

Camp is working on year-round programs and retreats for adults. Jackson is working on the summer program. Camp will host another summer program for kids who have been impacted by wildfires.

Outdoor School will start in March 2022 again.

New Business 2022

Recommended Budget | Libby Isensee: Libby pointed out changes in this year's proposed budget. The biggest change is in expenses-mostly with staff salary. Summer camp will be eight weeks this summer vs. seven weeks in 2021. Camp is increasing summer staff income to compete with other jobs in the job market.

For income, we are not sure how much grant money will be awarded to Camp or what grants will be available this year.

The budget is not balanced and there is a deficit of \$122,292. The Board felt comfortable recommending a budget that has

more expenses than income as Camp has more cash in the bank that was not spent last year. The goal also is to raise more income with programs and grants.

Discussion of Budget: No questions.

Budget Approval of 2022: Bill Johnson moved to approve the proposed 2022 budget. Second by Ruth Reno.

No discussion. Voted and passed unanimously.

Recognition and Presentation of Board of Directors

Nominees: There are no Board members who are leaving the Board this year.

The two new Board nominees are: Katie Plakos and Damien Ntawumpora.

Libby Isensee is on the ballot to be elected for a one-year term to complete the rest of her term. She left the Board in December 2021 to work as Camp Lutherwood staff. Eric Bohlmann and John Andrea are running for a second term.

Cathy Mueller moved to approve all five people on the ballot, the two for second terms, the two new Board members, and Libby to finish her last year. Second by Sarah Power.

Voted and approved unanimously.

Purpose of the meeting: This urgent meeting is being called to approve the purchase of 14.33 acres neighboring the east side of Camp. The Camp Lutherwood Association Bylaws state that special meetings must be called to approve the sale, lease, transfer, purchase, exchange, mortgage, or encumbrance of any property or buildings. A quorum of five congregations is required and each Association Congregation has one vote.

Welcome and Prayer: John Andrea, Board President.

Explanation of Property Opportunity: Andrea Scofield, Executive Director.

- The Association is the authority for any purchase, sale, or lease of property as per the Camp Lutherwood Association Bylaws.
- 2. Andrea gave a short history of the neighbors that have resided in the residence since the 1990's. The current owners purchased the property in October 2018 for the sole purpose of starting a marijuana grow operation. The operation was active for a little over three years and the smell was unbearable at times. The current owners live in Texas.
- This purchase is entirely separate from the ongoing Capital Campaign and no campaign funds will be used in the purchase of this property.
- 4. The property is located along the eastern border of the current Camp property. There are 14.33 acres plus a manufactured home, a stick built home built in 1972 with five bedrooms and three bathrooms. There is a garage, a barn, and a large greenhouse, plus other small greenhouses and two horse stables.
- 5. The property allows full access of the Camp Lutherwood Oregon water storage tank.
- The property also allows for expansion of the current Lutherwood driveway to join the new property as a loop so there is potential for a separate entrance and exit for Camp Lutherwood.

Additional Pros: Allow better parking and driveway, open up additional staff housing and allows for more expansion of the service/maintenance area of Camp. Barn can be used to store equipment, diversify activities on the entire property, and open up new possibilities for income. The parcel is zoned F2 which is a benefit since F2 allows for youth camps and building.

Cons: Lutherwood will have a long-term debt with the hope of paying off in less than five years. It will also require hard work to clean up the property to match the excellent condition of the current Camp Lutherwood property. It also will increase the overall insurance and maintenance for the camp.

Explanation of Financials: Bruce Henderson, Treasurer.

- 1. Plan for \$120,000. Down payment and then collateral is the property itself and not the entire camp.
- 2. The deposit will be raised and/or taken from the operating funds of Lutherwood.
- 3. We hope to have 45 days to finalize the escrow.
- 4. From 2010-2021, Lutherwood paid towards the \$500,000 MIF loan that financed the swimming pool and pool house rebuild. Since Dec. 2021, when the final pool loan was paid off, Lutherwood has been paying \$3000.00 into a deferred maintenance fund, essentially paying ourselves. This money can be used for the purchase of this loan. It continues to be considered an operational expense.
- 5. Three financial institutions were approached for financing the purchase. Mission Investment Fund (MIF) of the ELCA has the best rate (4.875) amortized over 25 years with no penalty for early pay off. The plan and hope are to have the loan paid in full within five years through donations and the operating budget.

Discussion and Questions Followed: All questions were addressed and then the motion was put forward.

Jim Krueger (United Lutheran Church, Eugene) moved that the Association of Camp Lutherwood Oregon allow the Lutherwood board of directors to purchase the property tax lot # 16-06-20-00-02100 in Lane County for a purchase price up to \$650,000. and to borrow the funds to do so. Seconded by Rev. Stuart Holland (Faith Lutheran Church, Junction City).


Motion Passed: 15 yes votes, 0 no votes, 1 abstain vote.

In January of 2022, none of us would have predicted that Lutherwood would own an additional 14+ acres along with four buildings. What a gift that is, with enormous potential for growth and opportunity. Nor did we realize the potential that renovating our 24' yurt and purchasing two more can bring. The new Upper Cabin restrooms will be a gift and blessing to all who are using the upper portion of Camp. The site report gives more detail but all of this is worthy of celebration.

During 2022, we completed a Strategic Planning process that included an update to our mission, vision, and values. This intentional work included voices from staff, community members, and board members. The plan will guide both staff and the board for the next few years.

The Lutherwood Staff team expanded by leaps and bounds. We have moved from a small team through COVID to a mighty team with some staff working remotely, as far away as Minnesota and Missouri. Together we will accomplish many things and work to fulfill our strategic initiatives and goals. Thank you to all the staff who have been an enormous part of the mission work at Lutherwood in 2022. Another reason for celebration in 2022 is the renewal of our American Camp Association (ACA) accreditation. the accreditation. We train staff to these standards and expect all staff to follow them in everything we do. It's a great accomplishment and honor to be recognized as a member!



As we approach each new year, we never know all the things that are in store for us but as we often say at Camp ... pay attention, listen, notice how the Spirit moves, and be open! We believe that 2023 brings even more potential and opportunity for growth and expansion.

Guided by our mission, we approach 2023 with open hands and hearts, allowing God's Spirit to surprise us along the way. We do our work knowing God is with us. Program Report

Summer & Fall 2022

In 2022, our summer theme was "Our Roots Run Deep." After a successful summer back at camp in 2021, we chose to emphasize our rootedness to God, camp, and one another in a world that is constantly changing. To keep



up with COVID health guidelines, our staff participated in biweekly COVID testing and practiced immediate quarantine for any symptoms or positive tests. We continued following 2021 COVID-19 protocols in the Dining Hall, eating buffetstyle meals and convening inside with the garage doors open.

For the 2022 season, we hired 20 summer staff and welcomed 65 family campers, 200 overnight campers, and seven Women's Retreat participants.

Campers enjoyed camp classics like the climbing wall, archery, and field games as we explored our roots at Camp Lutherwood together. Our brand-new curriculum was bolstered by the new theme songs written by our Spiritual Artist in Residence, Matthew Eagan. We plan to expand the curriculum with faith formation activities, community development, and personal growth opportunities. We also welcomed back Mental Health Specialist, Jennifer Noble, for a second summer. With the support of staff like Jenn and Matthew, our campers, families, and staff were able to grow in their spiritual and emotional learning.

2022 brought along the creation and implementation of Compass, developed for Lutherwood after our Camp Noah experience in 2021. The program incorporates traumainformed care practices as well as resilience training into a week of camp for 6th-12th graders. A grant from Lutheran Disaster Relief provided funding for the first three years of the program. In 2022, 18 youth from Lane County, Lincoln County, and Marion County participated in the program. We look forward to expanding this program in the next couple of years to encompass youth from a variety of backgrounds in addition to fire-impacted communities, including foster kids and families in the Eugene area!

In October, we hosted our annual LCMS retreat, inviting LCMS youth groups from the Willamette Valley and Southern Washington to spend three days and two nights exploring Camp during the fall. Two congregations joined us for an action-packed weekend full of leaf piles, karaoke bingo, and camp songs for a total of 16 campers and four youth leaders. Pastor David Lafore helped lead the Bible studies and sessions during the retreat, focusing on the theme of baptism. Campers, leaders, and staff alike had a blast and cannot wait for next year! We are already exploring ways to continue this partnership.

Looking Ahead: Summer 2023 will be a summer of trying new things!

Our theme is "Wonder," and we're inviting our campers to wonder about God's love and creation with us as we introduce our new five-day schedule and offsite trip progression. Each weeklong camp session will now end on Thursday evenings, with pick-up time after dinner. This schedule acknowledges that campers are still adjusting to the social challenges that the pandemic created while still providing four full days of camp fun. This change will also give our summer staff additional rest between camp sessions, enabling them to be at their best for each week of the summer.

In addition, all upper elementary, junior high, and high school campers will get the chance to participate in an offsite trip with their cabins. Trips will progress from a visit to a farm to learn more about where our food comes from, to a canoeing and picnic adventure at the nearby Fern Ridge Reservoir, culminating in a high school trip to a high ropes facility where campers will stretch out of their comfort zones and develop strong teamwork skills.

We understand that the unique thing about summer camp is the chance to create memories and experiences in nature. That's why we plan to emphasize activities that utilize the resources around us such as outdoor cooking and sleepouts. We cannot wait for our campers to enjoy these new changes with us!

Vision & Call Interns Report

Michael Girsberger and Gunnar Waage continued their work as Vision & Call Interns through May 2022. Michael was instrumental in assisting Lutherwood in renewing our accreditation with the American Camping Association (ACA). After his time with Lutherwood, Michael went to Lutherhaven Ministries in Coeur D'Alene to serve for the summer. Gunnar continued with Lutherwood, joining our Summer Staff for the second time where his leadership and experience were both appreciated and beneficial.


Masie Deiss

Guest Services Report

Not only is Camp Lutherwood a great place for a summer camp experience, but it is also a place for rest, renewal, and learning all year long!

In 2022, we once again hosted the Whole Earth Coyote Outdoor School program. Most of their weeks were run as day programs, with one week of residential programming. Throughout the course of the program season, Lutherwood hosted 2,354 Outdoor School participants.

We also hosted 767 guests through group rental use. In addition to welcoming back nine groups, including participants in the annual LCMS youth retreat and at Work Day in June, we also had the opportunity to host three groups for the first time: Springfield Faith Center, Grace Lutheran in Corvallis, and New Life Missionary Church in Portland. Each group enjoyed the quiet and beauty of camp while using their stay to reconnect, learn, and grow in community.

The fall of 2022 also saw a personal retreat space begin to take shape in Cascara cabin. By storing our summer health care items elsewhere, rearranging the space, and creating a wishlist of cozy blankets, pillows, and other hospitality items, Cascara is slowly becoming the perfect space for a personal retreat and sabbath. We hope to finish warm touches to Cascara in early 2023 so it's ready for your personal getaway later in the year!

In addition to improving Cascara, we continued to update and fine-tune our guest services process in order to give you, our guests, the best possible experience at Camp Lutherwood. This included updating our in-house forms, as well as creating new menu ideas, and evaluating our rental rates. Our staff also had some initial conversations around how to market the site for midweek meetings or gatherings for area businesses and groups. We are thankful for all who were able to use Camp Lutherwood Oregon in 2022 and look forward to welcoming even more groups to camp in the coming year.







Facilities Report

Tom Brewer, Site & Facilities Manager

It's been another busy year here at Camp Lutherwood Oregon! These are some of the projects we completed in 2022:

- We purchased a Better Built Barn and had it built on a tiny house frame. This building is our new program office. We insulated and drywalled the interior, and the exterior is now painted the same color as Cascara. We built a deck on the front with a ramp to make this building accessible to almost everyone. A generous donor donated the money to put a green metal roof on it to match the other buildings at Camp. We will also have an HVAC unit installed so this building will be comfortable year-round.
- Cascara has a new green metal roof as well. All of our buildings now have green roofs with the exception of the Craft Shed. The Craft Shed will most likely have to be removed to make room for the new Guest Lodge so until that is determined we will keep the current roof.
- We remodeled all four dorm cabins. We painted and put in new showers, vinyl flooring, and trim molding. We also updated the electrical wiring in Cedar and Willow.
- We primed, textured, and painted the walls and installed vinyl flooring in all six of the upper cabins.
- The pool house has been repainted inside and fullheight doors installed in each room to provide privacy for everyone.
- The new walking bridge across the creek past Lower
 Campfire (The Well area) is complete. This bridge is
 higher out of the water and all of the trees that formerly
 posed a hazard were either trimmed or removed. The
 first bridge that was rebuilt in 2021 was destroyed by the
 December 2021 storm so we are happy to have this new,
 higher bridge.
- The fence around the generator and garbage area behind the dining hall are both complete. We used wood from downed trees to make the fence as well as building a picket fence in the parking lot and in front of the cottage. It's great to use our lumber and portable sawmill for projects like these.
- We purchased a small building from Better Built Barns to use as a laundry room. We insulated, drywalled, and put electricity in the building. A friend of camp donated

- an almost new washer and dryer so we now have two washers and two dryers. This is a terrific addition since the loss of our laundry facilities in the 2019 fire.
- We have remodeled the kitchen in the site house. We
 painted and installed new cabinets and vinyl flooring. We
 also purchased new stainless-steel appliances. The heating
 system quit working, it was old and required a significant
 amount of money to repair. We purchased a new HVAC
 unit that's working very well.
- We purchased a new top and sides for our 24' yurt. We
 put down new plywood and vinyl flooring and added
 some better lighting. We also built a deck off of the
 front with a ramp to make it more accessible for almost
 everyone. The back has a porch with a ramp as well.
 Eventually, we'll install an HVAC unit.
- We purchased two 20' yurts to put in the "tent city" area. The platforms are complete. The yurts will arrive on the 16th of January. Eventually, these yurts will have vinyl flooring and HVAC units installed. These will have the flexibility to be used for summer staff housing, field study for Outdoor School, teacher gathering area for Outdoor School, and other ideas we have yet to imagine!
- The Cottage septic system failed this year and because it
 was too close to the Long Tom River, we decided to tie
 the Cottage septic into our existing system south of the
 bridge. This involved some engineering but was approved
 by the Department of Environmental Quality. The job
 was completed at the end of November. We had to pour a
 new sidewalk at The Cottage after the septic upgrade.
- The upper cabin restrooms are set to be completed by the end of January. This is a fantastic addition to the upper part of camp and will also accommodate guests in the new yurts.
- We have built firewood storage sheds up by the fire sprinkler tank and down by the lower campfire. We have plans to build a smaller one behind the fireplace in front of the dining hall.
- The five acres of forest thinning is complete. We have started thinning the six acres that have to be completed by the end of 2023 per our healthy forest management plan.

- There were a number of dead or dying trees around the dining hall. We hired an arborist to remove these trees.
- With financial help from a donor, we were able to buy a new 27-ton log splitter to help with the tons of firewood we have.
- We hired a company to do some mulching in the wet area of the forest south of the archery range. We will use this area during the summer months for various outdoor activities.
- The Long Tom Watershed's plan to put the log jambs into Luther's Creek has been put on hold due to lack of funding by the watershed.
- smoothly. The rooms of the main house are being primed and painted. The old carpet has been removed and we have plans to install vinyl flooring throughout. The barn will be cleaned up and will be our new shop area and storage. The old shop will be used for storage of items that get used frequently. We still have work to do on the grounds, i.e.: tree trimming, debris pick up, etc. We also need to re-create the access road to our water tank as well. The large greenhouse remains and we are beginning to make an overall plan for program use of the property.

I would personally like to thank the volunteers who faithfully come out once or twice a week to help on these projects. Without them, this list would not be half as long as it is. Thanks to Jim Krueger, Tom Mains, Tom Hellickson, Tim Knight, Jack Guthrie, Tom Dodd, Peter Kugler, Tim Vignos, Jim Barta, Bob Cook, and Kenny Jones.



Treasurer's Report

Bruce Henderson, Treasurer

I am pleased to report that despite the challenges posed by COVID-19, Camp Lutherwood Oregon was able to return to more normal operations in early 2022. The responsible financial management of our staff, finance committee, and board helped to maintain the organization's strong financial position, enabling us to expand our borders and create new opportunities. As a result, we were able to end the year in a positive financial position.

Operations Budget

Despite experiencing a 25% lower guest-based revenue compared to the budgeted numbers, we were blessed to receive a higher-than-anticipated amount of donations which was 65% over what we had budgeted for the year.

In 2022, Melissa and her team successfully secured a significant number of new grants for the organization, and they are working diligently to secure additional grants in 2023

Organizational Reserve

For the past several years, the board of directors has had a goal to have, at a minimum, three months of expenses set aside for any unforeseen circumstances. In 2022, there were funds that became available and the board approved their use to create an organizational reserve fund which is being held with Mission Investment Fund of the ELCA (MIF). We ended the year with \$208,256.39 in this fund.


New Property

On November 18, 2022, Camp Lutherwood successfully acquired the property to the east of camp, expanding the camp's borders by 14.33 acres. Thanks to our strong financial position and the support of several donors, we were able to make a \$120,000 down payment, avoiding placing the entire camp property as collateral for the loan. The remaining balance on the loan is \$480,000, and monthly payments will commence on January 1, 2023.


Investing in Our People
